### **MEMBERSHIP AGREEMENT/CONSENT INFORMATION**

**Registration Fee:** The Summer classes run June thru August. The School Year classes run September 2018 through the end of May 2019. A non-Refundable registration fee must be paid in order to hold a spot in a class for your child for either Summer and/or School Year classes. The **NON-REFUNDABLE REGISTRATION FEE** schedule is listed on the reverse side of this form.

**Tuition:** I understand the School Year tuition is based on a four-week payment schedule each month and that I am not charged extra for months that have five weeks in them. I agree to **pay full tuition each month** (even those with scheduled holidays) on the 1<sup>st</sup> of each month. Tuition received on the 8<sup>th</sup> of the month or after will result in a \$10.00 late fee. We do not mail reminders. **There are no refunds for missed classes.**

**Non-Payment:** If your account is 2 months past due for tuition, your child will be dropped from the class. The account will be sent to collections if payment is not received.

**Dropping a Class:** If you choose to drop your child from a class prior to the end of our School Year Classes, you must fill out a withdrawal Form \_\_ in the office. Simply not showing up for a class does not relieve you from paying for classes.

**Re-enrollment Fee:** If you decide at any time to reenroll after dropping within the same school year, you will have to pay a \$10 fee.

**WE REQUIRE A 2 WEEK WRITTEN NOTICE WHEN YOU WITHDRAW YOUR CHILD FROM CLASS.**

**ALL ACCOUNTS NOT PAID IN FULL WILL BE SENT TO COLLECTIONS AND REPORTED TO ALL MAJOR CREDIT BUREAUS.**

**Make-up Classes:** Any class your child misses other than our scheduled holidays, can be made up at Open Gym for free. All make-up for classes missed must be completed before the end of our School Year schedule session in May.

**Returned Checks:** There will be a \$25.00 Fee for all Returned checks or Credit/Debit card chargebacks.

**WAIVER AND RELEASE OF LIABILITY**

I fully understand that **Step Ahead Gymnastics and Dance** and **Jacksonville All Stars (JAS)** staff members are not physicians or medical practitioners of any kind. I hereby release **Step Ahead Gymnastics and Dance/JAS** staff to render temporary first aid to my child or children in the event of any injury or illness, and if deemed necessary by **Step Ahead Gymnastics and Dance/JAS** to seek medical help, including transportation by a **Step Ahead Gymnastics and Dance/JAS** staff member and/or it's representatives, whether paid or volunteer, to any health care facility or hospital, or the calling of an ambulance for said child should **Step Ahead Gymnastics and Dance/JAS** staff deem this to be necessary.

Parents should make their children aware of the possibility of injury and encourage to follow all the safety rules and the coaches' instructions. **Step Ahead Gymnastics and Dance/JAS**, it's coaches and other staff members, will not accept responsibility for injuries sustained by any student during the course of gymnastics, tumbling, dance, or cheerleading instruction, or open gym workouts, or in the course of any exhibition, competition, or clinic in which he or she may participate or while traveling to or from an event.

With the above in mind, and being, fully aware of the risks and possibility of injury involved, I consent to have my child or children participate in the Programs offered by **Step Ahead Gymnastics and Dance/JAS**. I, my executors or other representatives, waive and release all rights and claims for damages that I or my child may have against **Step Ahead Gymnastics and Dance/JAS** and/or its representatives whether paid or volunteer, I also affirm that I now have and will continue to provide proper hospitalization, health, and accident insurance coverage that I will consider adequate for both my child's protection and my own protection.
